

The Graduate/Junior Consultant Program

RMCG's Graduate/Junior Consultant Program will provide you with challenging and meaningful work, and structured professional development to help you navigate the beginning of your career.

We will work with each graduate/junior consultant to develop a program that features at least three placements (of approximately four months). You'll work from a central office location but some travel between offices and client sites will be expected. There is also an opportunity for each placement to be held at a different office location if convenient.

As a graduate/junior consultant you will:

- Be a part of and work with a diverse team of professionals
- Work across several technical disciplines
- Be involved in interesting and challenging projects
- Have access to both internal and external learning and development opportunities
- Learn and grow with mentors and a network of peers.

We will provide:

- A 12-month program, with 3 placements of approximately 4 months at a time
- The opportunity to develop technical knowledge and skills by working with and learning from others
- The ability to explore different areas of interest across the business

- Structured training to become a great consultant
- Access to mentoring and supervision that will guide and support you throughout the year
- A competitive starting salary of \$75,000 including super.

Completion of the Program will grow your body of knowledge and experience across a range of disciplines, assisting in identifying your future career direction, and allowing RMCG to best support you in getting there. This could mean continuing to work with RMCG, but could also see you working for another organisation or pursuing further study.

What our program involves

Our 12-month program is rich in professional development opportunities, field work, mentoring and support. You will have the opportunity to build strong relationships with your peers for additional support, feedback and learning opportunities.

PLANNING AND EVALUATION

At the beginning of a placement you will meet with your nominated supervisor and the rotation lead to discuss and set specific goals for the rotation. You will meet again at the completion of the placement to discuss achievements, performance and any areas of focus for the next rotation.

At the completion of the program, you will be expected to prepare and document your learnings and experiences to be presented at a combined staff meeting.

PROGRAM COORDINATION

Your day-to-day RMCG contact will be your nominated supervisor and managers of projects you are working on.

The Program will be managed by our HR Co-ordinator who can answer any questions about your placement.

Our ideal candidate


We are looking for graduates or early career candidates with qualifications and an interest in the following areas:

- Agriculture Farm business management and succession (dairy, horticulture, livestock, cropping, irrigated agriculture); research, development and extension; soil health and sustainable land management; carbon farming and accounting; workforce planning and development.
- Environment Catchment management, biodiversity and conservation management, water for the environment, project planning and analysis, resource recovery and waste management.
- Community Stakeholder and community engagement, cultural heritage, planning, facilitation, evaluation, co-design, systems thinking.
- Water Integrated water management (IWM), irrigation design and management, recycled water and domestic wastewater management, groundwater analysis, water quality and salinity.
- Resource Recovery Waste and water balance assessment, diversion opportunities and processing, reuse opportunities, market analysis and regulatory approvals.

WHO CAN APPLY?

To be eligible for the RMCG Program:

- You will have completed an undergraduate degree (within the last 12 months) or are in the early stages of your career, with one to two years experience
- Your degree or experience will be relevant to one or more of the disciplines above
- You are an Australian or New Zealand citizen, or an Australian permanent resident*
- You will have access to your own transport for travel between office locations.

STAGE 1:

APPLICATION - NOVEMBER 2025

To apply, you must submit a **resume and detail in 400 words or less why you wish to apply** for our Graduate/Junior Consultant Program and what skills and attributes you can bring to RMCG.

We also require a **copy of your academic transcript** or a statement verifying your qualifications if obtained overseas.

STAGE 2: INTERVIEW - DECEMBER 2025

We will shortlist applications and advise if you have been successful in progressing to an interview. We will also contact unsuccessful applicants.

At the interview you will be invited to talk about your skills, experience, achievements and what you can bring to RMCG. You will also have the opportunity to ask questions of the interview panel.

STAGE 3: OFFER - JANUARY 2026

If you are our preferred candidate, we will present you with an offer of employment, with the aim of the program commencing early February 2026.
